SBA Needs Project Evaluation Summary

Project Request:

Harrison County requests up to \$6,128,000 in SBA funding for additions and renovations to the United High School facility, which will become Gore Elementary School. These funds will be used in partnership with a local contribution of \$2,000,000 for a total project cost of \$8,128,000. Upon the completion of this project, the students from Adamston and Wilsonburg Elementary Schools will attend Gore Elementary. The existing Adamston Elementary School facility will be reconfigured to house students from United High School, and the existing Wilsonburg Elementary School facility will close.

Project Status:

Listed below are projected activities that have been completed to date.

- After reviewing the submitted documents and information, an on-site review was performed on 8/27/2019 with Dr. Mark Manchin, Superintendent and James Lopez, Assistant Superintendent of Harrison County Schools; Ernie Dellatorre, McKinley Architects and Engineers; and Joyce VanGilder, David L. Roach, Ben Ashley and Angie Bradley of the SBA Staff.
- On behalf of Harrison County Schools, a project budget and conceptual plan was established by McKinley Architects and Engineers.
- United High School serves as an alternative school that houses K-12 students from all areas of the county in five unique and innovative educational programs.

Project Comments by the SBA Staff:

- The modular design of Wilsonburg Elementary is well beyond its life expectancy. The wood floor framing and decking has a shallow crawl space that creates moisture issues throughout the school. Upon completion of this project, this facility will close.
- United High School will be renamed Gore Elementary and house over 500 PreK-5 students.
 Proposed interior renovations will include new flooring, ceiling, lighting, sprinkler and HVAC system upgrades. The exterior renovations include new windows, façade improvements, and separate bus and parent drop off points. A four-classroom addition is proposed to house Pre-Kindergarten students.
- Since this project was not funded last year, the county completed the additional steps that concerned the Authority during the last funding cycle. Closure hearings were held for Adamston Elementary School on December 3, 2018 and Wilsonburg Elementary School on December 4, 2018. The Harrison County Board voted to close Wilsonburg Elementary School and reconfigure Adamston School on October 1, 2019. The WVBE approved the closure and reconfiguring of both schools on October 9, 2019.
