### **Project Comments by the SBA Staff:**

- Currently, this is the only multi-story elementary school in Mason County that does not have elevator access to all levels. This project will allow the school to meet ADA requirements.
- As the elevator addition and other interior ADA improvements are made, the State Fire Marshal requires this facility to be brought up to current fire codes by adding a sprinkler system. This additional work is included in the project budget.
- This project has been listed in the county's CEFP plan since 2010 as an original project and not an amended need.
