### **Project Status:**

Listed below are projected activities that have been completed to date.

- After reviewing the submitted documents and information, an on-site review was performed on 9/26/18 with Jonathan Hicks, Director of Support Services of Tucker County Schools and Joyce VanGilder of the SBA Staff.
- On behalf of Tucker County Schools, a project budget and conceptual plan was established by Williamson Shriver Architects.

### **Project Comments by the SBA Staff:**

- The cooling tower has exceeded its life expectancy and the county maintenance staff fears that
  any maintenance or repair will permanently damage the equipment. Should the cooling tower
  fail, it would place Tucker County in a situation where the school would close. The control
  system components are failing, and replacement parts are becoming obsolete.
- The cooling tower is working at maximum capacity and is unable to cool and condition the entire facility, which creates high humidity in the classroom during hot weather. The older motors in blowers, fans and compressors are failing because of overheating due to the cooling tower's inability to maintain adequate temperature.
- The music room has been permanently placed on the stage which has limited air circulation and is served by a residential portable air conditioning unit. This project proposes to provide this space with its own dedicated unit.
