Project Status:

Listed below are projected activities that have been completed to date.

- After reviewing the submitted documents and information, an on-site review was performed on 10/1/2018 with Amanda Kimble, Director of Support Services of Tyler County Schools and Joyce VanGilder of the SBA Staff.
- On behalf of Tyler County Schools, a project budget and conceptual plan was established by ZDS Design/Consulting Services.
- Phase I HVAC renovations were funded by the SBA in a 2016 Needs Grant that totaled \$4,598,578 for the purchase of major mechanical equipment that included two new chillers, three new boilers, new hydronic pumps and first floor unit ventilators for classroom, library, media center, kitchen and commons areas.

Project Comments by the SBA Staff:

- As Phase II, this project proposes to upgrade HVAC systems that serve classrooms, gyms, the auditorium, band, and music areas on the upper level as well as the school's office suite, stairwell, and lowest level locker/weight room. A complete electrical system upgrade is proposed along with fire protection, sprinklers, and lighting system renovations.
- This project will complete a full mechanical and electrical system upgrade at this facility, which will address air exchange deficiencies and Fire Marshal concerns.
- Tyler County Middle/High School was constructed with SBA funding in 1993. The HVAC
 systems contained in this phase are nearing the end of their life expectancy. This is one of several
 SBA funded facilities from this time frame that we should expect to see requesting system
 replacements.
