Changes: Policy 6200 requires all local boards of education to submit amendments to CEFPs to the WVBE and the School Building Authority of West Virginia (SBA) for approval. The Pocahontas County Board of Education requests approval to make renovations to Pocahontas County High School the county's highest priority. These renovations include upgrades to the HVAC system, electrical system, windows, restrooms, and the addition of hallway connectors. The projects are planned to be funded through local funds and a grant from the SBA.

Dear members of the West Virginia Board of Education,

This letter is a request for approval to amend Pocahontas County Schools Comprehensive Educational Facilities Plan to focus on needs of our high school. The original building was built in 1969 and is in need of major upgrades to maintain a facility that will allow for the increase in safety precautions for our students and staff, energy savings, and upgrades that will accommodate the fast-paced and rigorous standards of today's technological environment.

The Pocahontas County Board of Education approved and have received our Needs Grant application which includes the CEFP amendment request. Our Board approved our application on September 3, 2024.

We have been awarded two Major Improvement Grants to provide electrical upgrades and the replacement of the floor in the high school's gymnasium. These two phases of our plan are underway, leaving phase three of our project: Phase three will be the HVAC system and replacement of the electric switchgear. This is also included in our CEFP as the first priority.

In addition to our original phase three request for the Major Improvement Grants, this Needs Funding Project also includes:

- Connecting hallways from the main building to the Career and Technical Education building;
- Upgrades to student restrooms;
- Replacement of geothermal heat pumps;
- Replacement of auditorium air to heat pumps;
- Replacement of main electrical switchgear;
- Upgrading data cabling;
- and replacement of exterior windows.

We appreciate the support of the revisions made to our current CEFP to prioritize our schools' needs.

Briefly describe the nature of the amendment and/or scope of work to be completed:

There is need for an upgrade of facilities at the High School to keep the building in a good state of repair and extend its useful life. The building opened in 1969 and many of the equipment is original to the building. The plan is to complete the following items and make them the top priority:

Add two hallway connectors from the main building to the CTE wing. This will improve student safety and security since the students will not need to walk outside between classes.

The geothermal HVAC equipment is over 20 years old and past the end of its useful life. Because of its age and poor condition, the equipment requires frequent repairs and failures impact student comfort and overall learning environment.

The auditorium HVAC is also 20 years old and at the end of its useful life. Like the HVAC in the main building, this equipment requires frequent repairs.

The electrical switchgear is original to the building and is outdated. The replacement of this equipment will preserve the long-term viability of the overall building.

Exterior windows are in poor condition and in a number of instances, windows are no longer operable. This is a point of concern since many of these are egress windows and their failure impacts student safety.

The lavatory near the gymnasium will also be upgraded to make it ADA compliant. This will provide a better learning environment for students.

The estimated cost of these upgrades is \$6,214,444 and the county is providing a local match of \$1,250,000 or 20%. The funds requested for this project is \$4,964,144.

The existing CEFP has some of these provisions for facility upgrades but does not include the replacement of HVAC in the auditorium, lavatory upgrades or new data cabling. This amendment more clearly describes the nature of upgrades defined in the 2020 CEFP. Those items include the geothermal HVAC, switchgear replacement, window replacements and connectors to the CTE wing.

 Provide the impact of this amendment upon the educational opportunities of students and the budget of the LEA. (Narrative)
The students of Pocahontas County will have a significantly improved learning environment as well as improved safety. These facility upgrades will help preserve the building for many years avoiding the need to construct a new building.

Critical health and safety are addressed by the construction of two connectors from the main building to the CTE wing so students will no longer need to walk outside between classes. The replacement of windows also positively impacts student safety allowing egress during an emergency. The lavatory upgrade will provide a better learning environment since it will be accessible for students with disabilities.

Demographic scenarios will not be affected.

No other counties will be affected other than by using our facility as an example for future programs.

The history of the LEA has been to attempt bonds and levies in the past. In the past 20 years, there has not been a successful passage of a bond or levy. A goal of this project will showcase how the proposed improvements being made at the technical center will be completed without passing a bond. This will likely incentivize voters to approve upcoming bond issues.

Pocahontas County Schools remains on a regularly scheduled maintenance program and will remain so throughout the future. Records are kept in School-Dude for review. This facility will fall under the same guidelines as all other district facilities.

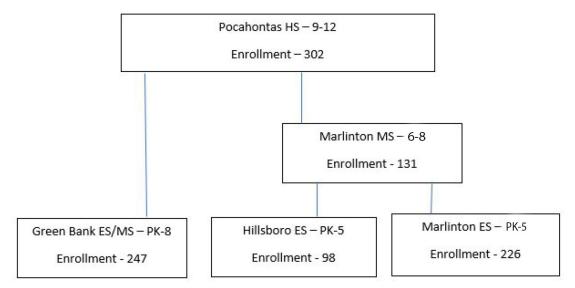
