#### **Project Status:**

Listed below are projected activities that have been completed to date.

- After reviewing the submitted documents and information, an on-site review was performed on 10/8/24 with Dr. Tony Minney, Superintendent of Gilmer County Schools, along with Patrick Elliott of the SBA Staff.
- On behalf of Gilmer County Schools, a project budget and conceptual plan was established by Williamson Shriver Architects.

#### **Project Comments by the SBA Staff:**

- The existing 500-gallon hot water tank (25 years old) and existing piping (66 years old) have exceeded their life expectancies. The water tank supplies the main building and the science labs. If the tank goes out, the school will have to be shut down until it is replaced. The tank shows signs of multiple leaks, and the top is completely corroded. Maintenance has spent between \$5,000 to \$10,000 on repairs in the last three years.
- The Ethylene Propylene Diene Monomer (EPDM) roof (28 years old) over the science classroom addition has exceeded its life expectancy. Leaks are a common occurrence, affecting hallways and some classrooms. During heavy rains, students have to be displaced for up to several days. The metal roof (26 years old) over the vocational building is showing signs of deterioration. This roof covers the new animal processing center and school clinic. Leaks have been occurring since 2015. Maintenance has replaced numerous galvanized screws and repainted the roof in 2016.
- Gilmer County proposes to replace the water tank and piping; and replace the EPDM and metal roofs.
