- After reviewing the submitted documents and information, an on-site review was performed on 10/6/23 with Melissa Mace, Superintendent of Lewis County Schools, and Mark Miller of the SBA Staff.
- On behalf of Lewis County Schools, a project budget and conceptual plan was established by William Shriver Architects.

Project Comments by the SBA Staff:

- Lewis County High School was built in 1994 with SBA funds. The HVAC system is original to the building and is failing in several areas. There are two nonfunctioning units in the auditorium, two in the gymnasium, and several down that serve classrooms. The system has reached its life expectancy, and the county staff have been working diligently to try to keep it functioning.
- Lewis County proposes to replace the existing HVAC system and controls at Lewis County High School. Additional VAV boxes would be added to all classrooms, improving efficiency. The existing fire alarm system will be upgraded to work in conjunction with the new HVAC system and controls. As the existing ceilings and outdated fluorescent lights are removed to allow for equipment access, new LED light fixtures will be installed.
