* This project proposes to replace the remaining rooftop units that were not replaced with ESSER Funds; install new lighting fixtures, new intercom system, new security system, new fire alarm system, and a new phone system throughout the main and adjacent buildings, as well as update the computer lab.

* This project proposes to upgrade switch gear and existing panels to four of six buildings. Additionally, SBCTC can connect more of the facility to a second water meter and create a water line loop with sufficient water pressure.

* This project proposes to expand the existing parking lot by creating 24 spaces next to the new HVAC classroom, along with additional storm drainage and site lighting. This project scope would also include adding metal security screens to the seven existing garage doors to allow airflow in the shop areas while keeping the building secure.
