* MOVTI is requesting funds for interior renovations. The main water shutoff valve and two primary branch cutoff valves	
are non-operational due to age. Whenever attempting to repair leaks, maintenance staff must contact the city to shut off the water at the street. The Tube Heating System in the majority of the high-bay shop areas is outdated, with replacement parts unavailable. Three HVAC units (PTAC) are outdated. The Vehicle Exhaust System in the Auto Lab has been non-functional for over 10 years, not providing proper ventilation to the area. Several high bay shop coiling doors do not operate properly, posing safety concerns for students and staff. Exterior door thresholds have rusted, allowing rain water	
 to enter the building. * This project proposes to replace the non-functioning water valves; replace the outdated Tube Heating System; replace 3 outdated PTAC units with new HVAC (Bard) units; replace the non-function Vehicle Exhaust System; replace 7 high bay shop doors; and replace the exterior door lintels.

Calhoun-Gilmer Technical	\$ 2,947,554
 Calhoun-Gilmer Technical Center is requesting funds for renovations to the ProStart kitchen area. CGCC was originally built in 1975. The kitchen/culinary instructional areas are outdated, undersized, and no longer meet recommended State health code standards. 	Ф <i>2,7</i> т <i>,33</i> т
* This project proposes to renovate, reconfigure, and expand the instructional kitchen and associated commons space, incorporating new commercial-grade kitchen equipment, updated finishes, and technology. Underutilized existing space will be repurposed to accommodate the expansion.	
M Due to funding limitations, the SBA recommends partial funding, limited to the ProStart Kitchen instructional area only, at an amount of \$2,265,260.

* Located in Grantsville, Calhoun County, CGTC serves students from Calhoun & Gilmer Counties.	
Roane-Jackson Technical Center	\$ 2,115,877
* RJTC was constructed in 1973. The current roofing system for buildings A, B, & C are approaching 20 years old and are failing in multiple areas. Maintenance staff have installed multiple patches throughout, which are starting to fail as well, allowing water infiltration and potential water damage. A recent wind storm lifted up a large section of the EPDM on building A, separating it from the underlying insulation and framework. This section is now being weighed down and held in place by multiple cinderblocks.	
* This project proposes to replace the existing EPDM roofing and insulation, replace damaged flashing, and remove two abandoned rooftop heating units from buildings B and C.	
* Due to funding limitations, the SBA recommends funding Roane-Jackson Technical Center's priority #2, roof replacement of Building B, at an SBA request of \$473,982.	
* Site visited on 4/25/25 by Patrick Elliott, SBA with Ben Cummings, Director, RJTC.	
* Located in Leroy, Jackson County, SBTC serves students from Jackson and Roane Counties.	
Fred Eberle Technical Center	\$ 2,055,459
* Currently, FETC faces some logistical challenges, such as the Cosemetology classroom being located across the parking lot from its corresponding lab. Furthermore, the classrooms being utilized for two medical programs are arranged in a manner that requires students to walk through one classroom to access the other, due to the space available when those programs were implemented. Lastly, there is no space available within the building to add new programs or efficiently restructure existing ones.	
* This project proposes to construct a new 4,800 sq. ft. building to house three specialized classrooms dedicated to Cosmetology, Licensed Practical Nursing, and Therapeutic Services. This new structure will be strategically positioned between the existing buildings, which should help foster a more cohesive and enclosed campus environment for students and staff. The vacated spaces currently housing those programs can be renovated to better serve the facility, including a large assembly room for orientations, specialized lectures, and large group activities. Though the new building will not be physically connected to the existing structures, its design will include a weather-resistent canopy that spans the space between the buildings.

United Technical Center	\$ 2,751,364
* The existing roof at UTC is beyond its 20-year warranty and incurs leaks each year. The sealed concrete floors in the shop areas are original to the facility and have deteriorated immensely. There are two buildings at the rear of the campus that once housed the former PIA program that have become inefficient storage sites. Lastly, the facility's only multi-purpose space is quickly becoming too small to accommodate the growing enrollment.	
 * This project proposes to replace its EPDM roofing and insulation, renovate and expand current facility space, and reseal the concrete floors in the shop areas. The renovations would include an expanded multi-purpose space and repurposing the rear buildings into both storage and classroom space. By addressing these various maintenance issues, they hope to strengthen the condition of the facility and upgrade their program offerings. UTC has prioritized the renovation of the two rear buildings should funding be limited. 	
 * Due to funding limitations, the SBA recommends funding United Technical Center's priority #1, to renovate the former PIA office and garage, at an SBA request of \$347,696. * Site visited on 4/29/25 by Mark Miller, SBA with Matt Call, Director, UTC. * Located in Clarksburg, Harrison County, UTC serves students from Doddridge, Harrison & Taylor Counties. 	
 South Branch Technical Institute * This facility has several plumbing issues. Toilets and sinks are original to the 1970's building and are not ADA accessible. The shop sinks have been replaced with cheap, plastic utility sinks. The restrooms for the middle school students are shared with the high school students. * This project proposes to install a new in-classroom single occupant restroom in the middle school classroom to avoid disruptions of students leaving this space. The project also proposes new fixtures, the installation of shut-off valves in multiple areas, the replacement of shop sinks, and to repair areas of the sanitation lines. * Site visited on 4/30/25 by Joyce VanGiler, SBA with Shelly Crites, Director, SBCTC. * Located in Petersburg, Grant County, SBTC serves students from Grant, Hardy, and Pendleton Counties. 	\$ 692,491
