# School Building Authority of West Virginia MAJOR IMPROVEMENT PROJECT COMMENTS BY SBA STAFF May 8, 2024

The staff of the SBA has performed an evaluation and prepared a report for each county that submitted a request for Major Improvement Project (MIP) grant funding. After reviewing the documents submitted, on-site reviews were performed by the SBA staff for each project to review the information and to verify the severity of need for the proposed projects. The staff was able to verify the existing condition of each facility based on reports from visits within the past year, and with information that was communicated by the County and/or their Architect / Engineer. All affected facilities were reviewed by the SBA staff and the interior and exterior conditions of each facility were examined to the fullest extent possible.

- I. Student health and safety including, but not limited to, critical health and safety needs;
- II. Economies of scale, including compatibility with similar schools that have achieved the most economical organization, facility use and pupil-teacher ratios.
- III. Reasonable travel time and practical means of addressing other demographic considerations.
- IV. Multi-County and regional planning to achieve the most effective and efficient instructional delivery system.
- V. Curriculum improvement and diversification, including the use of instructional technology, distance learning and access to advanced courses in science, mathematics, language arts and social studies.
- VI. Innovations in education.
- VII. Adequate space for projected student enrollments.
- VIII. The history of efforts taken by the county board to propose or adopt local school bond issues or special levies to the extent Constitutionally permissible; and
- IX. Regularly scheduled preventive maintenance; and
- X. How the project will assure the prudent and resourceful expenditure of state funds and achieve the purposes of this article for constructing, expanding, renovating, or otherwise improving and maintaining school facilities for a thorough and efficient education.

The information provided in the following summaries represent the SBA Staff's full and thorough evaluation of each county's proposed project. The Staff has made calculated funding recommendations as noted in each of the county's project description pages.

Grant County requests up to \$849,360 in SBA funding for a two-classroom addition at Maysville Elementary School. These funds will be used in partnership with a local contribution of \$200,000 for a total project cost of \$1,049,360.

#### STAFF COMMENTS

- Maysville Elementary has a high utilization and is becoming overcrowded due to population growth from the influx of families relating to the Corridor H expansion. With the growth, Grant County has created a wait list for students to attend this school.
- This project proposes to construct a two-classroom addition. This addition will help alleviate the high utilization and overcrowding.

#### MONONGALIA COUNTY

# Project as proposed by Monongalia County:

Monongalia County requests up to \$979,237 in SBA funding for a new outdoor learning space, kitchen, and commons area renovations at Morgantown High School. These funds will be used in partnership with a local contribution of \$875,000 for a total project cost of \$1,854,237.

#### STAFF COMMENTS

- Originally built in 1927, Morgantown High School (MHS) is currently home to over 1,800 students. MHS has a strong desire for an outdoor learning environment to be able to provide a STEM space which would allow students to explore and discover learning outside the classroom. Due to the age of the school, kitchen equipment is overdue for upgrades and repair parts are becoming obsolete. The kitchen layout, food preparation area and serving line no longer accommodate the increasing number of students.
- This project proposes to reconfigure the kitchen area to allow for better efficiency and flow for preparing and serving food. Renovations to the cafeteria, media center, and distance learning spaces will allow existing square footage to be better utilized according to the current needs of the facility. Minor renovations to the cafeteria to create a commons area and a reduction of the media center will create spaces for students to study independently or work in small groups throughout the day, not just during lunchtime.

#### STAFF COMMENTS

- The current wastewater treatment plant was constructed in 1980. It is nearly inoperable as multiple issues with the interior walls and pumps require constant maintenance. Parts are obsolete and the control panel has not operated properly for years. Degradation is substantial, and continued operation in its current state will become a health and environmental issue. There are holes in the sidewalls due to significant rusting, with the potential of raw sewage leaking out. The equipment is constantly failing and running improperly. The DEP issued violations in 2021-2022.
- This project proposes to demolish the existing wastewater treatment plant and construct a new one.
- This project meets the goals and objectives of the MIP program.

- This proposed project is the first phase in ultimately creating additional classroom/office space in the existing gymnasium basement. This proposed area does not meet fire code, as there is no fire suppression system. There is an outdated gas furnace that provides heat only. This phase proposes to install an HVAC system that meets current air quality standards, and an appropriate fire suppression system, including exit doors.

One classroom had to be moved due to water coming in contact with electrical equipment. There are numerous cracks along seams and patches, and multiple areas of wrinkling/bubbling.
- This project proposes to replace 130,000 square feet of primarily modified bitumen roofing, including the main roof area and food court/cafeteria, with a new 60 mil EPDM membrane roof. This incorporates the New Innovative Learning Center, several classrooms, the newly renovated Science Lab/Music Department, and the Physical Education locker and training room areas. This will prevent leaks that could potentially lead to further damaged tiles and equipment, as well as prevent the potential for mold growth.

- There are multiple (5) sections of roofing, with some sections being over 30 years old. It is reported that there is a high frequency of leaks throughout the building. Students must be relocated to other rooms, and one set of stairs has to be closed off during heavy rains. There are leaks near electrical equipment in the computer lab, the hallway near the elevator, and multiple classrooms throughout the building.
- This project proposes to remove the built-up roof and replace it with a new 60 mil EPDM rubber membrane roof; apply restorative coating; remove one section of the deck and add trusses and a metal roof.
