# West Virginia Department of Education Office of School Operations & Finance – School Facilities

**Introduction:** The Harrison County Board of Education requests approval of an amendment to their current 2020-2030 Comprehensive Educational Facilities Plan (CEFP).

**Changes:** Policy 6200 requires all local boards of education to submit amendments to CEFPs to the WVBE and the School Building Authority of West Virginia (SBA) for approval. The Harrison County Board of Education requests approval to revise its 2020-2030 CEFP to include the following changes:

- Liberty High School is proposed to be closed and merged into the existing Robert C. Byrd High School.
- Mountaineer Middle School and Washington Irving Middle School are proposed to be closed and consolidated into a new Liberty Middle School, which is planned to be housed in the would-be vacant Liberty High School facility. This consolidation would only occur if the proposed high school merger is approved.
- North View Elementary School is proposed to be relocated into a new Mountaineer Elementary School, which is planned to be housed in the would-be vacant Mountaineer Middle School facility. This relocation would only occur if the proposed middle and high school actions were approved.
- The county's project priority list is also being modified to add safe school entries to the proposed receiving schools, and the previously planned new facilities for Washington Irving and North View Elementary are being removed.

Changes in a county's CEFP are for planning only, and any proposed closures are pending the completion and approval of the official closure procedures found in Policy 6204, School Closings or Consolidations.

Briefly describe the nature of the amendment and/or scope of work to be completed: This application to amend the Harrison County Board of Education 2020-2030 CEFP will contain three action steps for our county realignment plan. Each action step is contingent on the prior action. The Harrison County Board of education is respectfully proposing the following.

# Action #1

The closure and merger of Liberty High School into the existing Robert C. Byrd High School beginning the 2025-2026 school year.

# Action #2

Close Mountaineer Middle and Washington Irving Middle Schools beginning the 2025-2026 school year. The students will be consolidated into the former Liberty High School that will be vacant as a result of Action Step #1. Liberty Middle School will be the new name of the school.

# Action #3

Move North View Elementary, beginning with the 2025-2026 school year, into the former Mountaineer Middle School, which will be vacant as a result of Action Step #2. Mountaineer Elementary will be the name of the new school.

Note- Washington Irving and is listed as the number one priority to be replaced in the 2020-2023 CEFP and North View Elementary School is listed as the number 3 priority to be replaced. This realignment plan will create a cost avoidance in the amount of -\$46,029,700.00 to the districts 2020-2030 CEFP budget.

Add secure entrances to receiving schools; Robert C. Byrd, Liberty Middle (Liberty HS) and Mountaineer Elementary (Mountaineer Middle).

#### Action #1

Originally built in 1995, Robert C. Byrd High School is a two-story structure that contains approximately 198,703 sq. ft. Due to declining enrollment there is currently space that is not being utilized. The campus contains all athletic facilities in addition to additional building and other site development. Overall, the building is in good condition. With the declining enrollment Robert C. Byrd High School has a 56% utilization rate based on enrollment at the end of FY23. Liberty HS has a building utilization rate of 39% and a student enrollment of 431.

#### Action #2

The current CEFP includes constructing a new Washing Irving Middle School at a cost of \$29,150,950.00. This will create cost avoidance of -\$29,150,950 to the 2020-2030 CEFP Total Project Budget.

#### Action #3

The current CEFP includes constructing a new North View Elementary School at a cost of \$16,878,750. This will create cost avoidance of -\$16,878,750 to the 2020-2030 CEFP Total Project Budget.

The total CEFP Budget of 120,216,873 will be reduced by not building new schools (WI \$29,150,950 and North View \$16,927,230) by \$46,029,70. The total amended CEFP budget is as follows; Current budget \$120,216,873 - \$46,927,873= \$74,187,175 (Total Amended Budget)

Add secure entrances to receiving schools; Robert C. Byrd, Liberty Middle (Liberty HS) and Mountaineer Elementary (Mountaineer Middle).

# C. OVERALL PLAN AMENDMENT (Complete Information on additional pages)

# Action Step #1

The Harrison County Board of Education (HCBOE) has experienced a loss in students over the past seven years. The overall student enrollment has decreased by 3,433 students from 2015-16 to 2022-23. Liberty High School currently has student enrollment of 431 student and a building utilization of 39 percent. Robert C. Byrd has a student enrollment of 56% building utilization rate.

The Harrison County Board of Education proposes to close and merge Liberty High School into existing Robert C. Byrd High School at the end of the 2024-2025 school year. The merger would provide the following:

- Meeting the Economy of Scale guidelines of the School Building Authority and the West Virginia Department of Education more closely.
- Housing all students in a more newly constructed facility.
- Increasing the utilization and efficiency of operations of all facilities.
- Improving school transportation efficiency.
- Accessing expanded curriculum, specialized staffing, and specialized resources as well as increasing the likelihood of more certified teachers in classrooms.

Liberty HS current enrollment of 431 students and RCB's 56% utilization rate, the school has the available space to accommodate the influx of students and staff from Liberty.

#### Action Step #2

Harrison County Schools is proposing to close Mountaineer Middle School and Washington Irving Middle School for the 2025-2026 school year. The students would be consolidated into the former Liberty High School that will be vacant as a result of Action Step #1. Liberty Middle School would be the name of the new school. This plan will provide for more efficient school building utilization and will vacate a facility to facilitate the county plan in Action Step #3.

Mountaineer Middle School has decreased by 114 students over the past ten years and is projected to decrease by another 34 students over the next ten years. The current enrollment of Mountaineer Middle School is 358 students.

Washington Irving Middle School is the number one priority in the current CEFP. Student population has decreased by 32 students over the past ten years and is projected to decrease by another 51 students over the next ten years. The current enrollment of Washington Irving Middle School is 535 students. The closure of Washington Irving would have been necessary due to the overall condition of the current building.

#### Action Step #3

Move North View Elementary School for the 2025-2026 school year into the former Mountaineer Middle School that would be vacant as a result of Action Step #2. Mountaineer Elementary will be the name of the new school. The current CEFP includes constructing a new North View Elementary School at a cost of \$16,878,750. Although it would have been potentially been funded through a future bond call, it significantly reduces the overall CEFP financial plan.

1. Describe how the amendment alters the current ten-year comprehensive educational facilities plan, project, finance plan, and changes in the scope of the project. (Narrative) The 2020-2030 CEFP, identified building new schools for Washington Irving Middle and North View Elementary (priority #1 and #3 respectively). The estimate cost in 2020 to replace Washington was \$29,150,950 and North View Elementary was 16,878,750. Due to the current inflation rate, the cost of a new buildings would be much higher. By relocating the students, the county no longer will need to construct a new school, therefor creating a cost avoidance to the overall CEFP budget amount by -\$46,029,700.

2. Provide the impact of this amendment upon the educational opportunities of students and the budget of the LEA. (Narrative)

In an effort to provide an equal and quality education to each student in Harrison County, the Harrison County Board of Education proposes to consolidate services. This would not only save the Board of Education operating expense, but it would also allow the county to provide an expanded educational curriculum for all students. The realignment plan with provide students with access to an expanded curriculum, specialized staffing, and specialized resources. Instruction will be enhanced with full time staff in art, music, wellness and counseling; more consistency of curriculum; opportunities for additional elective courses; and students will all have access to health care through our school nurses or Community Care of West Virginia. Students also will have access to a mental health care provider through Project AWARE and a licensed therapist in the building provided by Community Care of West Virginia.

3. Describe how the existing facility plan does not and the proposed amendment does meet the following goals of the SBA as described in WV Code §18-9D-16:

a. Student health and safety including, but not limited to, critical health and safety needs The 2020-2030 CEFP identifies building new schools Washing Irving Middle and North View Elementary. Both of these schools are nearly 100 years old.

b. Economies of Scale, including compatibility with similar schools that have achieved the most economical organization, facility use, and pupil-teacher ratios

The merger of Liberty HS with RCB (will house) approximately 1,100 students. The SBA indicates 800 students are required to meet Economies of Scale Guidelines for a 9-12 Configuration

The Consolidation of WI Middle and Mountaineer Middle (will house) approximately 893 students. The SBA indicates 450 students are required to meet Economies of Scale Guidelines for a 9-12 Configuration

c. Reasonable Travel Time and practical means of addressing other demographic considerations Action Step #1

The transportation routing schedule does not result in undue time in transit for students according to recommended age-appropriate travel times. Liberty High School is 4.4 miles from the receiving school of Robert C. Byrd High School. Transportation will evaluate the routes to ensure that the students are not exceeding bus ride limits.

#### Action Step #2

There are no negative variances with any of the bus routes, as the former Mountaineer Middle School is on the same campus as the new Liberty Middle School and already had buses running to that area. The former Washington Irving Middle School is 5.3 miles from the new Liberty Middle School, and would only add 10 minutes to the commute.

#### Action Step #3

There are small variances in the bus routes and the transportation routing schedule does not result in undue time changes in transit for students according to recommended age-appropriate travel times.

North View Elementary is 10 minutes (5 miles) from the New Mountaineer Facility but already has buses running to that area because of the feeder schools' proximity. North View Elementary currently feeds into two different feeder areas from fifth grade to middle school. The students who would normally attend the new Liberty Middle School, from North View will be bussed to

that campus as usual. The students who would normally attend Washington Irving Middle School in Clarksburg will also be bussed and placed at the new Liberty Middle School. Transportation will evaluate the routes to ensure that the students are not exceeding bus ride limits.

d. Multi-County and regional planning to achieve the most effective and efficient instructional delivery system

e. Curriculum improvements and diversification, including the use of instructional technology, distance learning and access to advanced courses in science, mathematics, language arts, and social studies

Students will have access to an expanded curriculum, specialized staffing, and specialized resource. Instruction will be enhanced with full time staff in art, music, wellness and counseling; more consistency of curriculum; opportunities for additional elective courses; and students will all have access to health care through our school nurses or Community Care of West Virginia. Students also will have access to a mental health care provider through Project AWARE and a licensed therapist in the building provided by Community Care of West Virginia.

#### f. Innovations in Education

Harrison County Schools ensures an engaging educational environment for learners focusing on teaching and learning in the 21<sup>st</sup> century. We will provide a safe environment with quality instruction and engaging opportunities for our students.

g. Adequate Space for projected student enrollments

#### Action Step #1

Robert C Byrd has a build capacity of 1200 and after the addition of the Liberty students will house approximately 1100 students.

Action Step #2

Liberty High School has a 1160 student building program capacity. The consolidation of WI and Mountaineer into the new Liberty Middle School will house approximately 893 students. Adequate educational spaces will be provided.

#### Action Step #3

Mountaineer Middle School has a building program capacity of 620 students. The moving of North View will house 270 students. Adequate educational spaces will be provided.

h. The history of efforts taken by the LEA to propose or adopt local school bond issues or special levies to the extent constitutionally permissible

Harrison County has an Excess Levy in place currently and has been fortunate to have the levy in place for the last 50 years. Harrison County has been unsuccessful in recent efforts to pass any bonds for school construction. The last successful bond was in 1990 that was the last large consolidation effort. Harrison County has been fortunate to receive SBA funding for projects in previous years both for Needs and Major Improvements that have allowed, with local matching funds, to maintain our facilities and build new schools. Norwood Elementary was our number two greatest CEFP need within our district school facilities. This project request and closure has allowed for the elimination of one of our oldest facilities built in 1924. Simpson Elementary was our number five greatest need in the CEFP for the building of a gym. It is currently our only Elementary School without a dedicated space for physical education or large group area.

i. Regularly scheduled preventive maintenance All schools in Harrison County comply with all preventative maintenance schedules and inspections.

j. How the project will assure the prudent and resourceful expenditure of state funds and achieve the purposes of this article for constructing, expanding, renovating or otherwise improving and maintaining school facilities for a thorough and efficient education The 2020-2030 CEFP, identified building new schools for Washington Irving Middle and North View Elementary (priority #1 and #3 respectively). The estimate cost in 2020 to replace Washington was \$29,150,950 and North View Elementary was 16,878,750. Due to the current inflation rate, the cost of a new buildings would be much higher. By relocating the students, the county no longer will need to construct a new school, therefor reducing the overall CEFP budget amount by -\$46,029,700. The plan will also eliminate the cost to operate the two oldest schools in our county, increase the utilization of our schools and address the trending decline in student enrollment.

# Harrison County Schools 100.016.2 Translating Educational Needs-Building Review

Building Review and Recommendations Report, compiled alphabetically by school.

#### **Adamston Elementary School**

#### **Describe Existing Facility:**

The school is very old and was constructed in 1907 with additions in 1935 and in 1993. The school's exterior has red brick walls and a flat roof. The interior of the school has concrete and/or wood flooring which has been covered with asphalt or asbestos tile and/or some carpet, painted plaster walls and suspended ceiling and lighting. Air conditioning units are mounted in the windows.

#### **Describe Existing Facility Site:**

The school is situated upon approximately two acres. The school fronts on west Pike Street and parking areas are somewhat

scattered. The school busses load and unload on 27th Street. The site is tight and is not easily expanded.

# **Recommendations for Future Use of Existing Facility:**

- Building Repair
- Exterior window and door replacement
- HVAC improvement
- Plumbing renovations
- Health and safety improvements

\*This school is already scheduled for closure and the students will be relocated to the renovated **Victory** Elementary (formally United High school).

Although originally planned to be called Gore Elementary, this consolidated school (Adamston and Wilsonburg) is transitioning its name to be Victory Elementary School.

The approved closure had identified Adamston as the location for the United High School students, but further analysis and stakeholder discussions have dictated that Wilsonburg be the site of the United High School students. This transition will take place once the new Victory Elementary (United HS Building) is fully renovated and the Wilsonburg students are relocated.

#### Cost Estimates for Recommendations:

This School is scheduled for closure Cost to Bring Facility up to Current Codes & Standards

\$7,558,922

#### **Big Elm Elementary School**

#### **Describe Existing Facility:**

Big Elm Elementary School was built in 1993 and is in overall good condition. There is some evidence of Effervescent on the outside split face block surface causes some cosmetic issues. The original dry pipe sprinkler system in this building is difficult to maintain and test. The Big Elm Elementary School is a one-story structure encompassing approximately 65,000 square feet. A section of the school contains a sloped roof with asphalt shingles and other sections have flat roofs. The exterior walls of the school included white and red split faced masonry block and the doors and windows are painted pink. The interior of the school contains asphalt and/or tile floor covering, painted masonry block and/or metal walls and suspended ceiling and lighting.

#### Describe Existing Facility Site:

Big Elm Elementary School is sitting on a large Rural site and could be easily expanded if required. The school contains 20 acres of reasonably rolling land. The site has a paved roadway from Route 20 up to the school. A paved school bus loading/unloading area and a large, paved staff and visitor parking area. The site contains a pre-school playing area and an additional play area for larger children. Both play areas are well equipped. The school contains a soccer field that is also utilized by other Harrison County schools.

Recommendations for Future Use of Existing Facility: Continue in current configuration.

- Finish upgrades and some exterior repair
- The sprinkler system upgrade
- HVAC upgrades

#### **Cost Estimates for Recommendations:**

Cost to Bring Facility up to Current Codes & Standards

#### **Bridgeport High School**

#### **Describe Existing Facility:**

The Bridgeport High School was constructed in 1963, is in average condition and received additions in 1992 and 1997. The high school exterior exhibits a flat roof and walls of clay-colored brick, masonry block and white stucco panels. The school contains approximately 98,152 square feet. The interior of the school has terrazzo, asphalt and carpet floor covering, clay-colored brick, masonry block and/or sheet rock walls and suspend ed ceilings and lighting.

#### Describe Existing Facility Site:

The Bridgeport High School site contains a paved bus loading/unloading area and a paved parking lot and a small parking area for the handicapped. The parent pick-up area is separated from bus traffic. The site contains approximately 22 acres. The school has access to a baseball field, a football stadium that has a rubber track, a storage area, dressing rooms, seating for 5,000 at game time and a concession stand. A softball field is located behind Bridgeport Middle School, and a football practice area is utilized as a soccer field. The middle and high school utilize all athletic areas. The existing site is currently in a flood plain and to put additions on the school will require fill to be brought onto the site to bring the building out of the flood plain.

#### Recommendations for Future Use of Existing Facility: Continue in current configuration.

- Replace cafeteria, kitchen, and gym on site adjacent to existing building
- Renovate existing Cafeteria into Science Classrooms, new office spaces with a security entrance
- Provide a STEM space and safe storage for computer charging
- Provide quarantine space in Nurses area.
- New finishes throughout
- Replace exterior doors as necessary
- Upgraded finishes
- Upgraded technology
- HVAC system replaced
- Mechanical upgrades
- Domestic plumbing, and sanitary plumbing Upgrades
- Complete sprinkler system
- New asphalt for parking

#### **Cost Estimates for Recommendations:**

Cost to Bring Facility up to Current Codes & Standards

\$15,729,823

#### Bridgeport Middle School

#### **Describe Existing Facility:**

Bridgeport Middle School was built in 1995 and is in average condition. It is a one-story split face block building with metal roofing and low slope roofing. Bridgeport Middle School contains approximately 106,000 square feet. The school has a portico at the entrance, supported gray block pillars. The exterior walls exhibit tan and gray split faced block. Also, the gutters and downspouts are blue metal. The HVAC units are located on flat roof. The interior of the school contains suspended ceiling and lighting, painted masonry walls and/or metal or drywall in some areas. The entrance and reception area appears to have utilized fritz floor tile and the remaining floors contain asphalt tile, carpeting and/or ceramic tile in several locations.

#### **Describe Existing Facility Site:**

The acreage for Bridgeport Middle School is 12.3 acres; however, it undersized in that only nine acres are usable. The school is located adjacent to the Bridgeport High School. The school staff and visitor parking and bus loading/unloading area is paved and adequate as well as the parent pickup area. The

middle school has a softball field behind the school. Bridgeport Middle School is on the same site as Bridgeport HS but is mostly out of the floodplain.

Recommendations for Future Use of Existing Facility: Continue in current configuration.

- HVAC repairs and replacement
- Rooftop heat recovery units replaced.
- New water source heat pumps

#### **Cost Estimates for Recommendations:**

The building is in fair condition but needs some immediate upgrades to the HVAC System and some of the low slope roofing. Propose to prioritize HVAC, roofing and exterior doors. Cost estimate for the proposed work \$4,369,843.

Cost to Bring Facility up to Current Codes & Standards \$9,077,152

#### Johnson Elementary School

#### **Describe Existing Facility:**

Johnson Elementary School was completed in 2018 and is in excellent condition. 65,310 square feet, load bearing structure in new condition. Steel joist roof system in new condition. Structure meets all current safety/security requirements of SBA.

#### **Describe Existing Facility Site:**

The project site is adjacent to Bridgeport High school, but the site was raised out of the floodplain. 11acre site with excellent drainage. Playing fields and access roads are more than adequate. The site is small for the school but the overall site for the three schools is more than adequate.

Recommendations for Future Use of Existing Facility: Continue in current configuration.

- Addition for expected growth.
- New interior finishes
- Furnishing and equipment improvements

#### Cost Estimates for Recommendations:

Cost to Bring Facility up to Current Codes & Standards

#### **Describe Existing Facility:**

The Liberty High School was constructed in 1971 with additions in 1991 and 1993. The exterior of the school is yellow brick and has a flat roof. The interior of the school contains suspended ceiling and lighting, painted masonry block walls and terrazzo, asphalt tile, asbestos tile and/or carpeting on the floors. The school is in average condition. *The exterior windows at this facility are inoperative.*

# **Describe Existing Facility:**

A four-story building originally constructed in 1927. The overall condition of this building is poor. The school exhibits a flat roof and a yellow brick exterior. The interior of the building contains suspended ceiling and lighting, painted masonry block and/or plaster walls and asphalt tile floor covering. The air conditioning units are through the windows. An elevator serves all floors. The exterior walls have evidence of water infiltration. The street parking is very limited.

# Describe Existing Facility Site:

The school site is 1.5 acres which is substantially below the recommended guidelines. The school building takes up much of the site and there is very little room for a children's playground or any new additions to the school. The site contains only several spaces for parking which results in most of the

school staff and visitors parking on the street. North View Elementary is on a crowed urban site with limited parking and not room for growth.

#### **Norwood Elementary**

#### **Describe Existing Facility:**

Three story building constructed in 1924. The school's exterior exhibits a flat roof and brick walls. The interior of the school has suspended ceiling and lighting, painted plaster walls and asphalt tile floor covering. Overall the building is in poor condition. There is water infiltration through the exterior masonry walls. There is no Building Automation System in this building. There are issues with roof drainage piping in this facility. The sanitary sewer has deteriorated terracotta and cast-iron piping. A portion of outside sanitary has been replaced.

#### Describe Existing Facility Site:

The school site is approximately two acres of fairly rolling land and is considerably less than current guidelines. The rear of the site contains play areas. The front of the school faces Kidd Avenue where bus loading/unloading occurs. The small parking area on the site is inadequate, resulting in staff parking in the Catholic Church parking across the avenue. *The site is very small with no room on the site for parking or expansion.*

# **Nutter Fort Elementary**

#### **Describe Existing Facility:**

The Intermediate school contains approximately 48,000 sq. ft. and shares a dining area, kitchen, and multi-purpose room with the Primary school. The exterior of the original Nutter Fort school contains a sloped roof, a red brick exterior and painted exterior masonry walls to somewhat match the red brick. The exterior of the 1994 structure contains a flat roof and gray, brown, and pink masonry split face block with matched painted windows. The interior of the school contains suspended ceiling and lighting, asphalt floor tile and carpeting, painted masonry block walls and some plaster walls. The overall condition of this building is good.

#### **Describe Existing Facility:**

The school has two stories, and the exterior exhibits a flat and sloped roof, and split face masonry block walls which are gray and white. Windows and doors are painted green. The interior of the school exhibits a floor covering of terrazzo in front of the building and in some hallways. Asphalt tile and carpet covers the remaining floors. The walls are primarily painted masonry block and in most areas of the school, ceiling and lighting are suspended. The overall condition of the facility is average.

Boilers as part of the water source heat pump system are nearing the end of its life cycle. The roof at this facility is near end of life cycle expectancy.

#### Describe Existing Facility Site:

The site contains 130 acres; however, only 50 acres are usable. The high school, school athletic complex, parking area, bus loading/unloading area and play areas appear level. The interior of the school contains terrazzo flooring in the commons area and asphalt tile covering on the remaining flooring with the exception of the gymnasium floor which is wood. The interior walls are painted masonry block. 30% of the building is protected by a fire suppression system. Overall, the condition of the facility is average. Although the building is dated, overall, it is in good condition.

# Describe Existing Facility Site:

The high school fronts on WV Route 18 between Lost Creek and West Milford in a rural setting. The site, which is shared with the middle school, and the new Lost Creek elementary that is being added to the Middle school this year contains approximately twenty acres and lies below Route 18 and falls slightly. # **Describe Existing Facility:**

Washington Irving Middle School exhibits a flat roof and red brick and tile exterior walls. The interior of the school exhibits a substantial amount of suspended ceiling and lighting, painted masonry walls, concrete flooring in the basement and first floor, and wooden flooring or carpet on the second and third floors. The vestibule floor covering is terrazzo. The school has good windows, and the air conditioning units are installed under the windows. The school contains an elevator. Washington Irving Middle School

was built in 1914 and the building is in poor condition. The building is not suitable for modern classroom instruction. The exterior walls are deteriorating, and the doors and windows need replacement. The building is not compliant with existing electrical codes and the HVAC system need to be replaced. The fire alarm system is outdated, and the building does not have a fire suppression system.

The school is bounded by narrow city streets on all sides. *The school is on a tight urban site that is lacking parking and adequate play areas. There is no room for expansion on the site.*

Asphalt tile and fritz tile cover the remaining hallways, classrooms, and other areas with the exception of carpeting in the library and wood floor in gymnasium. The school is located on a suburban site on a five-acre site, most of which is reasonably level. The bus loading and

The majority of the school contains suspended ceiling and lighting, paneling and/or painted masonry block walls and asphalt tile flooring with the exception of the gymnasium that has a wood floor. The condition is fair, but the building was never designed for long term use. Much of the materials used to construction the building are showing signs of deterioration and the building walls are leaking and there are moisture issues in the crawl space under the building.

# Describe Existing Facility Site:

The school site is in a rural setting on approximately 4 acres of reasonably level land. Traffic patterns are separated from playing fields and circulation patterns. 


# United High School Summary Report

# This facility serves the alternative education needs of the county.

The approved closure had identified Adamston as the location for the United High School students (UHS), but further analysis and stakeholder discussions have dictated that Wilsonburg be the site of the UHS students. This transition will take place once the new Victory Elementary (UHS Building) is fully renovated and the Wilsonburg students are relocated.

Due to construction at the current United High School building, its students were temporarily relocated to the old Hartman Elementary School. Since the closure of that school, this facility was used as the offices for RESA 7, but most recently it was sold to a developer and subsequently repurchased by the county for the purpose of temporarily housing UHS students. The facility was sold for \$41,800 in 2019 and repurchased for \$40,000 in 2021.
